REMARKS: Disclosure in terms of final judgement and order dated 10.09.2024 passed by the Hon'ble Gujarat High Court in Special Civil Application No.8773 of 2024: (1) As per the communication dated 07.12.2024 of the State Tax Officer, Bhavnagar, a charge of the Value Added Tax Department operates on the immovable property (Lot No.2) described/mentioned herein above vide attachment order dated 28.01.2021 read with attachment order dated 12.07.2024 passed by the Assistant Commissioner, Commercial Tax, Bhavnagar.
